- 3. The promotion of the above officials will come into effect on the date of assumption of charge of the promoted post.
- 4. The above officials will be on probation for a period of two years from the date of promotion.
- 5. In case any vigilance/disciplinary case is pending or punishment is current against any official, he/she should not be allowed to assume charge of the promoted post without obtaining specific orders from this office.
- 6. The option for fixation of pay under FR-22(1)(a)(i), if any, shall be exercised by the officials within one month from the date of assumption of charge.
- 7. The officials, who are presently officiating as Inspector Posts shall be reverted to the substantive cadre of Postal Assistant/Sorting Assistant before assuming charge as Inspector Posts on promotion.
